Council News

1. S109 - Winton Drive - final water connection

The following communication has been received from the Council:

"Just for your info emergencies will be back on Frogston Road West – Winton Drive the final water connection; new notice date is 17th November but I have asked John to start on the 18th November due to the overnight A720 diversion.

 Tuesday 18th Nov for 1 week under 3 Way (2 Phase) Temp Traffic lights. Manual controlled 7am-7pm Monday to Friday"



2. Buckstone Play Park - update

Councillor Savage received a disappointing response from Council Officers.

"As promised at the last FCC meeting, I've got an (albeit disappointing) update, as can be seen below:

"I can confirm that there are currently no plans to refurbish the playpark at Buckstone Circle. While the Scottish Government funding has been very welcome, it has only allowed us to target around 20 playparks for refurbishment and approximately 65 for partial improvements, such as the replacement of obsolete equipment or safety surfacing. With a total of 179 playparks and wheeled sports areas across the city, we've unfortunately only been able to improve about half of these facilities using the funding available."

Upon learning this though, I (Conor) 've pushed to see what can be done to acquire more funding, to which I've got this reply:

"Our primary source of third-party funding for playpark projects comes from landfill grant

5. A720 Edinburgh City Bypass – further resurfacing

The questionnaire is hosted on the Council's Consultation Hub:

7 October 2025, I mentioned this further resurfacing. It seems to be never ending along the whole stretch of the Edinburgh City Bypass.

Originally the section of the Bypass Westbound from Straiton to Lothianburn was to be closed overnight between Tuesday 28 October 2025 and Monday 17 November 2025 (15 nights), with the diversion route being the "Bypass Relief Road", namely Frogston Road West.

I have now been advised by BEAR Scotland that the resurfacing will start a night earlier on Monday 27 October 2025. The end date and traffic management remains the same. "Following meetings with the contractors, there have been some changes to the work programme and traffic

The Information Bulletin for August 2025 mentioned the second public drop in event which was held on Thursday 14 August 2025. Midlothian Council have now lodged the formal planning application which summarises the development as follows: -

It is unclear where the funding for the A701 Relief Road is coming from. The Council is also planning to create a "sustainable travel corridor" along the A701 which will include cycle lanes. The Council also says "the road network suffers from congestion at peak times, resulting in traffic delays and inconsistent journey times for both vehicles and public transport." The deadline for submitting

comments on the planning portal is 7 **November 2025.**I attach a copy plan indicating the Proposed Route, together with pages 9/10 of the Transport Assessment which outlines the key features of this proposal.

A reminder that the consultation on the new tram route closes on Monday 17 November 2025. It is hosted on the Council's Consultation Hub: https://consultationhub.edinburgh.gov.uk/

A presentation on this project was given at the EACC Meeting on 11 October 2025. Here are some of the points made - It is understood that as at 11 October 2025, some 4,000 responses had been submitted (I understand the figure is now 5,700). A figure of £2.9bn has been suggested as the possible cost of the project, but this does not include any disruption costs to residents and businesses

caused by the construction etc works. If the project is given the go ahead, it is likely to be delivered in phases. There will be major engineering works required if the option to use the Queensferry Road is

chosen. Funding is not in place at present, but the Business Case for the project is required now, so that one is ready should the situation change. Police Scotland

9. Vehicle Crime - Ring Doorbell/ Home Security Cameras

Neighbourhood Watch Scotland

- "Following an increasing trend in reports of criminals placing tape over the cameras of ring
- doorbells and home security cameras in order to steal vehicles, Police Scotland urge you all to be aware, be vigilant, and be prepared!
 - Check your physical camera regularly for signs of it having been tampered with.
 - Check the feed is working properly and that your camera covers the areas you need to. Use adequate lighting, uniform illumination across areas covered by CCTV is vital.
 - Try not to use single floodlights. In the hours of darkness illuminate areas that are overlooked from residential areas or by CCTV. Report any suspicious activity you capture.
 - Ensure your cameras are charged and that you keep up with any subscriptions. Ensure your vehicles are as secure as possible. (for more information on vehicle
 - security go to Protecting your car Police Scotland).
 - Use Faraday bags to protect your keys' signal from being captured and allowing your vehicle to be stolen by keyless entry."

10. Darker Nights

Dark nights are drawing in and the clocks change this Sunday - 26th October

So, it's a good time to review home security, e.g.

Cut back shrubs and trees so they are not blocking lights or lines of sight

Check outside lights are working

Check garages and sheds are secure – consider ground anchors, garage defenders, shed alarms, anti-grinder bike locks

Check windows have key operated locks fitted, that catches, latches and stoppers are in a good state of repair - don't leave keys in the locks

Check door locks – that any mortice locks are British Standard BS 3621 and any Euro profile
